OTTAWA: Health Canada is informing Canadians that five brands of unauthorized eye drops (listed in table below) labelled to contain a prescription drug (neostigmine methylsulfate) have been seized from two retailers, Cube Inc. and Magic Queen Cosmetics in Richmond, B.C. (Aberdeen Centre 4151 Hazelbridge Way). These products may pose serious risks to the health of Canadians.

ST. JOHN'S: Canada's "oldest" provinces and territories need more health transfer funds to look after their rapidly-growing seniors populations, Dr. Chris Simpson, president of the Canadian Medical Association (CMA), said.

OTTAWA: Health Canada released its Third Report on Human Biomonitoring of Environmental Chemicals in Canada. This technical report provides the results of the biomonitoring component of the Canadian Health Measures Survey (CHMS) and presents comprehensive data on the exposure of the Canadian population to environmental chemicals, such as triclosan, and several volatile organic compounds (VOCs).

OTTAWA: Health Canada is taking additional steps to minimize the risk of liver damage and improve acetaminophen safety. This action is in light of a Health Canada review that assessed acetaminophen and liver injury in the Canadian context, a summary of which is available on Health Canada's website.

TORONTO: The introduction of the chickenpox vaccination program for children in Ontario was associated with a 71 per cent decrease in doctor office and emergency room visits and a 59 per cent decrease in hospitalizations for this disease, new research from Public Health Ontario (PHO) has shown.

MONTRÉAL: Leukodystrophies are deadly neurodegenerative diseases that affect one in 7,000 children and remain incurable. These genetic diseases attack myelin or the "insulating rubber sheath" surrounding neurons, which leads to deteriorating health for affected children. Today, nearly 20 types of leukodystrophies have been characterized, but many other forms remain undefined, leaving nearly 40 per cent of families awaiting a diagnosis. An international research team, led by Dr. Geneviève Bernard from the Research Institute of the McGill University Health Centre (RI-MUHC) and Dr. Benoit Coulombe from the Institut de recherches cliniques de Montréal (IRCM), has identified a new gene associated with 4H leukodystrophy, one of the common forms of the disease. Their findings have been published in the journal Nature Communications.
