DORVAL, QC: Quebec patients living with COPD now have access to Ultibro® Breezhaler® with its addition to the list of medications of the Régie de l'assurance maladie du Québec (RAMQ) as "Médicament d'exception" for the treatment of patients with COPD whose symptoms are not adequately controlled after a three month trial with a long acting bronchodilator. The Quebec government has become the first public payer in Canada to reimburse Ultibro® Breezhaler®. It is available in pharmacies province-wide.

TORONTO: Merck, known as MSD outside the United States and Canada, has confirmed its commitment to research and innovation by contributing a total of \$7.5 million to the Structural Genomics Consortium (SGC) Toronto and its network, thereby becoming a member of the consortium.

OTTAWA: Since the first notification at the end of March 2013, China has been reporting to the World Health Organization (WHO) confirmed cases of a type of avian influenza virus in humans identified as A(H7N9). Most cases develop severe pneumonia and breathing difficulties with some resulting in death.

OTTAWA: Canada's Chief Public Health Officer, Dr. Gregory Taylor and Dr. Bonnie Henry, British Columbia's Deputy Provincial Health Officer have confirmed that the second individual in B.C. has now tested positive for the H7N9 avian influenza strain. As noted by health officials on January 26th, the husband and wife recently returned to Canada from China.

WINNIPEG: The Honourable Rona Ambrose, Minister of Health, and Canada's Chief Public Health Officer, Dr. Gregory Taylor, have announced that one of the Public Health Agency of Canada's mobile laboratory teams in Sierra Leone is returning to Canada after successfully concluding its mission working with Doctors Without Borders on the Ebola outbreak response.

OTTAWA: The Government of Canada has published the results of the 2013 Canadian Tobacco, Alcohol, and Drugs Survey (CTADS), which demonstrate progress made in sustaining all-time lows in smoking rates, while also highlighting the need for continued attention to issues such as marijuana use among youth and prescription drug abuse.

OTTAWA: Health Canada is reminding Canadians about the risks of purchasing unlicensed home-use diagnostic test kits following recent compliance and enforcement actions undertaken by the Department.
